<b>TOURNAMENT CHECK-IN / BRIEFING DATE</b>	January 31, 2024 <b>REGISTRATION REMINDER:</b> All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. <b>You will be fined for being late.</b>

<b>OFFICIAL REGISTRATION / ON SITE CHECK-IN</b>	2:00 pm to 4:20 pm via Time slots. Time slots will be emailed tournament week.		
<b>TOURNAMENT BRIEFING</b>	Virtual - All Contestants must view.		
<b>OFFICIAL PRACTICE DAYS</b>	January 27–31. <b>ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS @ 12:00 PM LOCAL TIME ON CHECK-IN DAY.</b> During official practice, competitors may only fish with other competitors per Rule 3ii.		
<b>PRE -TOURNAMENT OFF-LIMITS</b>	Off-limits will begin on Saturday, January 13, and extend through Saturday, January 27 @ safelight. During this time you are not allowed on tournament waters. During the Off-Limits period, practice, and competition, anglers cannot solicit, gather or intentionally receive any information from anyone other than another competitor in the tournament.		
<b>TOURNAMENT WATERS</b>	<b>Lake Okeechobee and all rivers, creeks and canals connecting to Lake Okeechobee. You are only allowed to lock into J &amp; S Canal, Taylor Creek, Buckhead, Henry and Lakeport. Only that water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants.</b> <b>No Locking into the Kissimmee River Lock, Port Mayaca Lock (St. Lucie River) and the Moore Haven Lock (Caloosahatchee Canal).</b>		
<b>FISHING LICENSE</b>	Florida is required. Online: <a href="https://myfwc.com/license/">https://myfwc.com/license/</a>		
<b>FISH LIMITS</b>	Pro-Angler: 5 fish / Co-Angler: 3 fish / 12" minimum length

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.			
<b>Deposits are non-refundable and non-transferable regardless of date of cancellation.</b> Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
