| OFFICIAL PRACTICE DAYS | June 15 – June 19. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS @ 12:00 PM LOCAL TIME ON CHECK-IN DAY. During official practice, competitors may only fish with other competitors per Rule 3ii. | |
| PRE -TOURNAMENT OFF-LIMITS | Off-limits will begin on Saturday June 1 and extend through Saturday, June 15 @ safelight. During this time you are not allowed on tournament waters. | |
| TOURNAMENT WATERS | Tournament waters will be Lake Eufaula and any creeks and canals connected to Eufaula. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. | |

| FISH LIMITS | Pro-Angler: 5 fish / Co-Angler: 3 fish / 14" minimum length | |
