OFFICIAL PRACTICE DAYS	<b>November 9-11</b> . ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on <b>November 12</b> . During official practice, competitors may only fish with other competitors per Rule 3ii.			
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Sunday October 12 and extend through Sunday, November 9 @ safelight. During this time you are not allowed on tournament waters.			
TOURNAMENT WATERS	ake Okeechobee and all rivers, creeks and canals connecting to Lake Okeechobee. You are only allowed to lock into J & S Canal, Taylor Creek, Buckhead, Henry and Lakeport. Only that water open of ALL public fishing will be considered tournament waters. Any waters closed to public fishing with the contestants. We closed to this tournament's contestants. We Locking into the Kissimmee River Lock, Port Mayaca Lock (St. Lucie River) and the Moore Have Lock (Caloosahatchee Canal).	ill
